10:15 a.m. Call to Order

Meeting with Hīpu'u High School Parents

- S. Osborne opens meeting with explanation of Hīpu'u high school closure.
- Question and answer session with students, families, faculty and staff.
 - o (Jessie Kalawe) How will the reduction in force affect Hīpu'u faculty and staff?
 - S. Osborne provides answer about staff reductions; no details provided regarding number of cuts and nature (i.e., type of positions). Details indicated as forthcoming pending meeting with interim KOKL principal on Monday, 6/1.
 - 'Ohana Kalawe concerned about level of support that will be provided to Hīpu'u middle school program.
 - 'Ohana La'a (Aunty Kēhau) shares experiences with the Hīpu'u program;
 summarizes highlights of program.
 - Question asking clarification about the criteria and parameters for charter school renewal (from L. Young).
 - S. Osborne replies. Anecdotal history of struggles with charter school commission staff given.
 - H. Barkhoff replies indicating the commission staff's lack of familiarity with needs of rural communities and neighbor islands.
 - Student comments and questions from Lahapa Kalawe. Student indicates frustration with Hīpu'u high school not continuing; gives summary of Hīpu'u experience vis-a-vis her experiences as a kaiapuni (immersion) student. Expresses that Hīpu'u helped her transition to English language based education.
 - Kumu, Pua Mendonca, comments that Hīpu'u high school closure is a school level--specifically school board--decision.
 - H. Barkhoff addresses the rationale for closure.
 - P. Mendonca comments on inequity of decision making; rationale for

program closure does not take into account the equality of Hīpu'u and campus based programs, students.

- M. De Coito shares concern from teacher perspective; shares need for planning in advance in order to develop and carry forward the educational program.
- Jessie Kalawe shares concern that Hīpu'u program has not been addressed and treated as an equal component of the school. Upset that Hīpu'u families not given adequate notice (only two weeks before end of school) of closure of school.
 - K. Kaupiko addresses J. Kalawe. He expresses desire for Hīpu'u high school to be re-started pending "rebuilding" of program from middle school up.
 - J. Kalawe points out that virtual learning doesn't work for all students; but, the ones for whom it does work, Hīpu'u is a great fit.
 - J. Kalawe asks for a forum not restricted by time constraints. She acknowledges that it is not as useful, however, if the decision to close the Hīpu'u high school program is irrevocable with regard to coming school year.
 - H. Barkoff indicates that board can hear proposals for program reconsideration.
 - P. Wilhelm indicates that feedback can be given to board in writing, including via email.
 - A. Low shares that families currently feel "dissed." There is a need to repair relationships.
- 'Ohana Jack shares mana'o that challenges of distance, virtual learning, will not go away. The key is to build the education program in order to overcome such challenges.
- S. Rushing, kumu, shares frustration that faculty were not apprised of change in proposal regarding closure of high school. She turned down a position with another school with the understanding that Hīpu'u faculty were going to be vital to the structure of the education program for SY 2015-16.
- Meeting with community of school on topic of Hīpu'u high school closure closes at 12:10 p.m.
